He emphasizes the importance of harmonizing professional success with personal life.


His approach to work and leadership is grounded in authenticity, drawn from real-life experiences rather than just theoretical knowledge.

1. That Special Moment

One fine day, you started writing poems/stories. How did it happen exactly?

Mrs. Roberts, in the fifth grade, led the class in songs to teach grammar.

Miss Payne by high school, opened the door to Poe and Faulkner. When the old white guys who ran my hometown insulted teenagers, I took to the pen, writing editorials for the high school newspaper.

The pen is stronger when emotions are high.

Happiness dulls creativity.

2. Art Is Work

What exactly does your writing job consist of? What are today's main challenges?

Passive voice, jargon, bullet points were drilled in over my 30 years in big business.

A foot-high stack of handwritten stories demonstrates my quest to overcome that legacy.

My “job” is developing courses, researching technology’s impact on people and organizations, and writing articles.

My other self wrestles with life’s lessons, missed opportunities, and immense opportunities.

This resulted in a memoir, *Hand on the Shoulder: Finding Freedom in the Confluence of Love and Career*, published in 2022.

My “job” requires a deep dive into AI and its implications for people and organizations.

How do we balance AI's amazing capabilities with our need to maintain our humanity?

I'm struggling with this every day.

In summary, I was trained as an engineer and have been spending the rest of my life trying to get a liberal education.

3. Without Projects, There Is No Future

What are your most representative projects? What projects are you currently working on?

I recently used an AI application, NotebookLM, to analyze my 365-page book, develop a podcast summary, develop detailed overviews, and deep analysis.

Then I started asking questions, as if interviewing myself.

The answers sent me reeling.

AI made connections, produced new analyses, and insights I had never imagined. I'm still struggling with the emotional impact, but I will use writing to help me think through it.

Pen and paper, the deliberate letter-by-letter, word-by-word work will help me understand and express the event.

I was a judge in the 2023 Dashiell Hammett Prize sponsored by the International Association of Crime Writers.

But “well-crafted” did not produce a result that was a pleasure to read, nor a style I would emulate.

4. The Scent of Creation

Describe a scent that immediately transports you to a moment of inspiration or creativity. What emotions does it evoke, and how does it influence your creative process?

Two come to mind.

The scent of freshly cut wood, with a hint of machine oil, brings me back to the tiny basement workshop where my Dad and I repaired broken furniture, designed and built furniture, and repaired broken appliances.

Soon after he died, that workshop was the place where my tears exploded.

The second is perfume. It's rare, and its name eludes me, but it triggers scenes of a long-ago relationship.

5. Ink and Intimacy

If your writing style were a tactile experience, what texture would it be? How does putting pen to paper or fingers to keyboard make you feel on a deeply personal level?

Right now, my style feels like corduroy, ridged, as if in rows and columns.

My favorite poet, Rita Dove, published a book of poems, *American Smooth*.

I want to be smooth, punctuated by an occasional earthquake.

I'm a touch-typist, so typing is easy and feels natural.

But I'm also left-handed.

Paper, pens, and other handwriting paraphernalia are designed for right-handers. I grew up smearing ink.

Recovering from a divorce, I followed a project to Paris, found a tiny apartment in a renovated manor house by the Seine, then settled in for my first adult experience of being alone.

Friends said, "You're running away from your troubles."

My answer: "Damned right!"

But, each day, pen went to paper to write my feelings and descriptions of my new experiences; some resulting in a newsletter back to people in the US.

7. The Palette of Dreams

Imagine your creative mind as a painter's palette. What colors dominate your artistic spectrum, and how do they represent the different facets of your imagination?

Interesting question for a partially color-blind person.

I have no memory of colors.

If the police ever asked, "Describe what the assailant was wearing,"

I probably could never answer, unless it was a person with dark skin in a yellow shirt.

Yet, blue palettes appeal to me.

8. The Quill of Vulnerability

What truths and vulnerabilities would you unveil if your creative expression were a handwritten letter to your inner self? How does exposing your innermost thoughts contribute to your artistic identity?

This is a nagging struggle.

Thirty years in corporate leadership positions taught me to be stoical, determined, decisive.

Writing a memoir helped open a sliver of my vulnerabilities, but what secrets are between the lines of those stories?

I've toyed with fiction to free me of constraints, but the struggle goes on.

Consider a character or theme in your work that represents the shadows of your psyche. What does this shadow teach you about your fears, desires, or unexplored areas of your creativity?


Is this the case?

Hand on the Shoulder lists many of those memories, but early struggles fashioned my revolutionary tendencies.

I graduated from high school at sixteen and was always the smallest kid in any class.

That taught me to use my mental strategies rather than physical strength to meet my goals.



An analysis of **R. Grant Tate's** published articles, primarily on the Medium platform, reveals a consistent and interconnected set of thematic concerns.

These writings serve as extensions of the core narrative established in his book, applying his personal philosophy to broader societal and business challenges. His thought leadership is built upon three central pillars: a trenchant critique of the state of modern leadership, a human-centric approach to the challenges and opportunities of artificial intelligence, and a philosophical exploration of finding purpose in an increasingly chaotic world. Each theme reinforces the others, creating a cohesive worldview that is both critical of the status quo and prescriptive in its proposed solutions.

The Crisis of Modern Leadership: Beyond Seminars and into the Soul, a central tenet of **Tate's** work is the argument that contemporary leadership is in a state of profound crisis.

In his article "Is Leadership Dead? Or, just asleep at the wheel?", he diagnoses a fundamental paradox:

While the leadership development industry is booming—replete with "consultants, trainers, professors, coaches" offering an endless supply of books, webinars, and retreats, our institutions are increasingly fragile, trust is at historic lows, and individuals feel "unmoored".

He dismisses the efficacy of superficial interventions like a "flashy seminar or motivational speech," asserting that "something deeper is broken" that cannot be fixed with conventional methods.

Tate's critique is not aimed at individuals but at the systems that shape them.

He posits that our core institutions are failing to cultivate genuine leaders.

Education systems, in his view, are adept at teaching "knowledge, but too rarely teach wisdom."

Corporations are structured to reward "short-term profits over long-term stewardship," and the political sphere prizes "winning over governing."

The cumulative effect of these cultural forces, he argues, is that we "groom people to manage tasks, not to lead souls".

This systemic failure produces managers who may be competent but lack the foundational character required for true leadership, which he defines by courage, humility, and integrity—qualities forged not in a workshop but through experience, failure, and moral testing.

His proposed solution is a return to a more humanistic and character-driven form of influence, which he encapsulates in the central metaphor of his keystone work: the "hand on the shoulder."

This metaphor is the unifying thread that connects his personal memoir to his professional philosophy, transforming the title of his book into the brand identity for his entire worldview.

He explicitly makes this connection, writing, *In Hand on the Shoulder*, I wrote about how leadership feels more like a quiet presence than a shouting voice".

This "hands-on-the-shoulder leadership" is defined by "presence, not performance," emphasizing quiet guidance, steadfast support, and the slow, patient work of earning trust.

By repeatedly using this phrase, he transforms a book title into a memorable philosophical concept, making his platform more cohesive and his message more resonant.

This public philosophy appears to be deeply rooted in a specific and personal sense of professional betrayal. In discussing his book, **Tate** makes a pointed reference to his encounters with a "CEO who diminished IBM's culture".

This statement, juxtaposed with his profound admiration for the principles laid out by IBM's founder in Thomas J. Watson Jr.'s book

A Business and Its Beliefs suggests that his critique of modern leadership is not an abstract exercise. It is a direct reaction against the perceived degradation of a principled, humanistic model of capitalism that he once valued.

His critique of corporations that prioritize short-term profits over long-term stewardship directly mirrors the cultural shift he appears to have witnessed firsthand.

In this light, his entire philosophy on leadership can be understood as a sublimation of personal and professional disillusionment.

He is universalizing his specific disappointment with the direction of a once-great corporate culture into a general theory of leadership failure, lending his arguments an emotional weight and authenticity born from direct experience.

Navigating the New Frontier: AI, Ethics, and Human-Centered Technology, **Tate** extends his humanistic framework to the defining technological challenge of our era: the rise of artificial intelligence.

His writings on the subject, such as "AI Fatigue Is Real. Here's How to Stay Sane and Still Be Informed" and "The Muse is a Machine: Rethinking Inspiration in the Age of AI," reveal a nuanced and balanced perspective.

He acknowledges both the psychological burden of the relentless AI hype cycle ("AI Fatigue") and its transformative potential as a creative partner that can reshape the very nature of inspiration ("The Muse is a Machine").

This worldview is the practical application of his "hands-on-the-shoulder" philosophy, scaled up from one-on-one leadership to a general approach for navigating life.


It represents a fundamental belief in bottom-up change, where societal healing and progress begin with the transformation of the individual and the cultivation of authentic, supportive relationships.

His writing consistently argues that it is in these quiet acts of connection that individuals can find the stability and purpose needed to withstand the howling winds of a turbulent world.






